A board resolution (bank employees will often call it “BR”) is a resolution passed in a Board Meeting authorizing certain persons in a company to open and operate the bank account of a Company (Private Limited or Public Limited) or Limited Liability Partnership (LLP). A company is considered a separate legal entity (consider it as another person), the board resolution is required for opening a bank account in addition to other documents.

RESOLVED: That the Company execute and deliver to said bank a duly signed original of the completed banking resolution as is hereto attached, and the authority to transact business, including but not limited to the maintenance of savings, checking and other accounts as well as borrowing by the Company, shall be a contained in said resolution with the named officers therein authorized to so act on behalf of the Company as specified hereto.

Corporate resolutions do not normally need to be submitted to a state or federal agency. Instead, they should be maintained with the other important documents of the corporations, such as the books and the meeting minutes. If a shareholder wants to review actions taken by the corporation, then the resolutions should be in a place where they are easy to find. Be sure to review your state's recordkeeping requirements to ensure that you are keeping the records for the proper length of time.

A certified corporate resolution is a resolution made at a directors' or shareholders' meeting that has been approved by the secretary and president of the corporation. This type of resolution is useful if a bank or other external organization ever requires verification to permit specific actions or powers, such as the authority to sign documents on behalf of the corporation.
