By submitting the form to the court, the community service center confirms that all the data contained is accurate and true.

A judge may sometimes allow an offender to choose the type of community service they wish to do. If this is the case, a government or independent agency must verify that the offender completed the community service. Otherwise, a judge will order a specific type of service that is verified through the organization where the offender performs the work.

Community Service Information. THERE IS NO ONLINE COMMUNITY SERVICE. As a condition of supervision the courts often impose a sentence to do community service. Offenders are ordered to participate in a form of reparation to the community by performing work for NOT-FOR-PROFIT organizations. Not-for-profit organizations benefit by having the opportunity to use the services of offenders ordered to perform community service.

If you are a court-ordered volunteer, you must make sure the opportunity you are applying for allows court-ordered volunteers to earn community service. If the community service order in any given case deviates from the identified methodology for determining community service hours, reasons for the deviation shall be documented in the case record. The community service program may provide the Court, releasing authority or probation department, where applicable, with a written request for a modification to the order with rationale for the request.
