Import Procedure: Import trade refers to the purchase of goods from a foreign country. The procedure for import trade differs from country to country depending upon the import policy, statutory requirements and customs policies of different countries. In almost all countries of the world import trade is controlled by the government.

### Procedure and Steps Involved in Import of Goods

Generally, an exporter prepares a proforma invoice mentioning details of the description of goods, number and kind of packaging, marks and container numbers, quantity, rate, amount, etc., as per the contract. The importer returns the signed copy of the proforma invoice, which becomes part of an export contract.

### Export-Import Procedures (With Flow Chart)

Receipts of documents The importer's bank receives the documents from the exporter's bank. The documents include bill of exchange, a copy of bill of lading, certificate of origin, commercial invoice, consular invoice, packing list, and other relevant documents.
