Written Exams: All applicants to be a New York private investigator will be required to pass a private investigator exam that is offered by the state. You will need to pay \$15 and score 70% or higher. New York Private Investigator Training Certified training is not required for private investigators in New York.

### Become a Private Investigator in New York, NY Private ...

The private investigator test is in a written, 60 question, multiple choice format. Test appointments are two hours in duration, 75 minutes of which is the allotted test completion time. Test results will be made available within five business days of completion of the test. The cut score for the private investigator test is 77 per cent.
